Warren Equipment Company 401(k) Savings Plan

Your future is important to us at Warren Equipment Company. We offer a 401(k) retirement plan that puts you in control and with flexible contributions and employer match, the future is yours. Unsure about where or how to invest? We'll help with that too. Our 401(k) savings plan is offered through Bank of Oklahoma Financial who will get you started and help guide you through all stages to be prepared.

- Upon hire, you are automatically enrolled in a Traditional 401(k) plan at a 6% contribution rate, unless you opt out or change contributions through WEC Life.
- You can contribute between 1%-100% of your salary up to the annual federal limit.
- Warren Equipment Company will match 50 cents to every \$1 contributed. Maximum company match is 3% (based on 6% employee contribution).
- Company contributions have an annual vesting schedule of 25% per year, with employees being 100% vested in all contributions after 4 years.
- A Roth plan is also available for employee contributions and is eligible for the employer match. All employer contributions will be made into a Traditional 401(k) plan.
- To help enrich our employees financial knowledge, BOKF representatives hold quarterly meetings via either in-person or virtual webinars.

Identity Protection

Blue Cross Blue Shield provides identity protection services to eligible members and their families at no cost to them through Experian®, an independent company. Identity Works checks consistently for signs or risks of identity theft, by closely monitoring your personal information, alerting you of new activity and helping you recover if you are a victim of identity theft. Identity Works has a U.S. based Fraud resolution team to help investigate and address fraudulent activity. Members of the program can also check Experian® credit reports for past inaccuracies and signs of identity theft. Identity theft insurance up to one million dollars is available to members at an added cost. Enrollment is required annually and is done through the BCBSTX member portal.



Tuition Reimbursement Program

At Warren Equipment Company, we believe education is important! That's why we'll help you continue your education, by offering tuition reimbursement after 90 days of full time employment. Classes must be directly related to your position or another role with Warren Equipment Company. Classes must be approved in advance. The maximum reimbursement for tuition and book expenses is \$5,000 per calendar year after completing the course successfully with a C or better (or a passing grade if the course is pass/fail).

Employee Dependent Scholarships

Your family matters to you, so they're important to us, too. Dependent children of Warren Equipment Company employees are eligible for college assistance to encourage them to pursue higher levels of formal education. You must have completed two years of service by the beginning of the semester for your dependents to be eligible. The amount of each award is determined by the qualification of each candidate and the number of candidates participating each semester. Applications are taken in January for the Spring Semester, and September for the Fall Semester. Human Resources will send an email to all employees when the application window opens.

Paid Time Off (PTO)

Taking time away from our jobs to recharge, to be with loved ones, or run those essential errands is important to us all. With the PTO program, you get more flexibility, convenience, and control over how you want to manage your time off for life's experiences. You start earning PTO right away and can use it as soon as you earn it. Hours are accrued bi-weekly.

Warren Equipment Company allows qualified CAT® technicians to purchase tools through the Warren CAT Parts department interest free and paid through payroll deductions. Technicians can maintain up to a \$1,500 balance on a tool account.

■ Tool Credit

Building a toolbox can be expensive! Warren Equipment Company helps qualified Cat technicians purchase tools by giving them a \$100 credit each quarter to purchase tools through the Warren CAT Parts department.

Profit-Sharing

Based on annual financial performance, the Company may award a year-end profit-sharing bonus. This distribution consists of two parts: an additional 401(k) contribution equal to the total company match received during the previous fiscal year, followed by a potential second payment based on salary and prorated for active service during the plan year.

Employee Referral Bonus Program

Do you know someone who would be a great coworker? Refer them to us, and it could mean cash in your pocket! Once hired, simply fill out the Employee Referral Form on WEC Life. You will receive \$500 for a standard referral, \$2,000 for a Tech I or II, or \$4,000 for a Tech III or IV. All referral bonuses are paid in two installments: you receive 50% after the employee has been with the company for 30 days and the remaining 50% after the employee has been with the company for 6 months.

PWR Awards

We all want to feel valued and appreciated for the work we do. The PWR program is an online social media-type platform that allows you to recognize other employees in appreciation of their behaviors, efforts and results that align with our company goals and values.

PWR recognitions can be given with a point value, which translates to a cash value that you can use to purchase merchandise. Points are replenished each month for employees to award others.
